ERIN SEWAGE PUMPING STATION

Contract: 2022-03W

The Town is constructing a Sewage Pumping Station in Lions' Club Park in Erin Village as part of the Council-approved Erin Wastewater Servicing Project. Construction has started with the contractor preparing the site. This work includes erecting fencing along the perimeter of the site, site grading and set-up of the site trailers.

Due to site accessibility conflicts with other nearby construction works, the construction of the sewage pumping station will require the use of the entire Lions' Club Park property, as seen in the map below. This will require the temporary removal of the playground equipment, removal of an additional five (5) trees and the installation of a temporary construction access road across the park from Lions' Park Ave. to the sewage pumping station site on the north end of the park.

Upon completion of the sewage pumping station, the temporary construction access road will be removed, the playground equipment will be re-instated in its original location, a new pavilion will be built and the monuments re-instated at the south end of the park.

This change means that the entire Lions' Club Park property will not be accessible to the public for the duration of construction.

All trees and shrubs that were removed at the park will be replaced with new trees and shrubs, with Lions' Club Park restored to its original, or better condition.

Anticipated Construction Completion: Fall 2025

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience inconveniences such as restricted access to the park and surrounding areas, increased truck traffic around the park, dirt on roads, dust and noise. The Town, along with the Contactor, will make every effort to minimize these impacts to the community.
- The Town will not be responsible for damage to any privately owned items on Town or County property.

	Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday. Work after hours or on weekends may be required during the course of construction.
	Area Restrictions: To complete the work in a safe manner, there will be restrictions around the park area including temporary road/lane closures. The Town's Contractor will be erecting temporary fencing around the construction site; unauthorised access to the fenced area by the public is prohibited.
