

## INTERIM TAX BILLS DUE MARCH 28

THE TOWN OF ERIN PASSED ITS 2024 INTERIM TAX BYLAW IN JANUARY WHICH AUTHORIZES THE COLLECTION OF 50 PER CENT OF THE TOTAL TAXES FROM THE PREVIOUS YEAR.

PLEASE BE ADVISED THAT THE INTERIM BILLS GOING OUT NOW VIA MAIL AND EMAIL WITH THE FIRST INSTALLMENT DUE ON MARCH 28 REFLECTS THE 2023 TAX RATE.

BILLS SENT OUT IN THE FALL WILL REFLECT THE THREE PER CENT INCREASE APPROVED BY COUNCIL IN THE 2024 BUDGET.

RESIDENTS ARE ADVISED TO CONFIRM THEIR ADDRESS AND THEIR MUNICIPAL PROPERTY ASSESSMENT CORPORATION (MPAC) ASSESSMENT. THERE IS A \$20 FEE FOR RE-ISSUING A TAX LEVY STATEMENT.

## HALF-LOADS NOW IN EFFECT

UNDER TOWN OF ERIN BY-LAW #08-17, HALF-LOAD RESTRICTIONS ARE NOW IN EFFECT ON SOME ROADS IN THE TOWNSHIP. ROADS SUBJECT TO HALF-LOAD RESTRICTIONS WILL BE CLEARLY MARKED BY SIGNAGE STATING WHEN THE RESTRICTION ENDS.

IN THE SPRING, LOAD RESTRICTIONS ARE IN PLACE WHEN ROADS ARE SUBJECT TO SPRING THAW BREAKUP IN ORDER TO PROTECT THE ROADWAY'S SURFACE AND SUB-SURFACE. THE BY-LAW COMES INTO EFFECT MARCH 1 WHEN SIGNS ARE ERECTED ON THE SECTION OF ROAD IN QUESTION.
