This Notice is being issued under subsection 59 2(a) of the *Clean Water Act, 2006* and was prepared in response to an Application (as described above under Description / Supporting Documents) received for the property that is identified above. One or more of the land uses proposed to be engaged in or engaged in, at the above noted property, has been designated as a restricted land use under Section 59 of the *Clean Water Act* and the application is either for a provision of the *Planning Act* prescribed under Section 62, Ontario Regulation 287/07 of the *Clean Water Act* or for a building permit under the *Ontario Building Code*.

The Application was reviewed in accordance with the *Clean Water Act* and the *CTC Source Protection Plan* which came into effect on December 31, 2015. Based on the

information submitted as part of the Application, Section 57 (Prohibition) or Section 58 (Risk Management Plan) of the *Clean Water Act* **do not** apply, at this time, to the activities outlined in the Application for the above referenced property.

Rationale: The applicable policies relate to the prohibition of dense non-aqueous phase liquids (DNAPLs). For purposes of the zoning bylaw amendment, Section 57 and 58 do not apply to this application as the policy only prohibits certain chemicals and not the proposed use (RV sales and service). Discussions are ongoing with the applicant to confirm which chemicals sold or used are DNAPLs and to enforce the prohibition as required. This will be reassessed during site plan. As part of the site plan application, it is requested that the applicant complete a spill response / chemical management plan as per Section 4.9.5.4 of the County Official Plan.
