

THE CORPORATION OF THE TOWN OF ERIN Office Consolidation

By-Law #19 - 60

(amended by By-laws 20-44, 21-32)

A by-law to establish fees and charges for various services provided by the Corporation of the Town of Erin, and to repeal By-law 17-63

For Reference Purpose Only. Not a legal document/By-law.

Whereas Section 391, Part XII of the Municipal Act 2001 authorizes a municipality to impose fees or charges on persons;

And whereas pursuant to Section 385, Part XI of the Municipal Act, 2001 a municipality may fix a scale of costs to be charged as the reasonable costs of proceedings under Pat XI, which scale shall be designed to meet only the anticipated costs of the municipality;

Now therefore the Council of the Corporation of the Town of Erin hereby enacts as follows:

- 1. That the fees and charges for various municipal services provided shall be set out in Schedule A attached hereto, and forming part of this By-law.
- 2. That where the provisions of this By-law may conflict with any other By-law, this By-law shall prevail.
- 3. That should any part of the By-law, including any part of the schedules attached hereto be determined by a Court of competent jurisdiction to be valid or of no force and effect, it is the stated intention of Council that such invalid part of the By-law shall be severable and that the remainder of this By-law including the remainder of the schedules attached hereto, as applicable, shall continue to operate and to be in force and effect.
- 4. That this by-law be known as the Fees and Charges By-law.
- 5. That By-law 17-63 be repealed and replaced with this By-law.
- 6. That this By-law shall come into force and take effect on the date of its passing.

Building Permit Fee Schedule

- 1. Permit fees will be charged as outlined in Table 1.
- 2. Any building permit not otherwise listed in Table 1 will be assessed at 1% of its construction value. Construction values submitted are at the discretion of the Chief Building Official.
- 3. Fireplaces, HVAC, plumbing, attached garages, decks and porches are included in the permit fee for new residential buildings not more than three (3) storeys and not exceeding 60om2where submitted plans for the new building include these details.
- 4. Post approval revisions, equivalents, inspections outside of normal working hours that are authorized by the Chief Building Official and inspections to clear deficient permits will be charged at the rate of \$75.00
- 5. Permit extensions will be charged \$75.00
- 6. Where work or construction is carried out or commenced prior to permit issuance, the municipality shall be compensated for the additional expenditures required because of the unlawful commencement of the work. The minimum fee charged shall be 100% of the required fee based on the entire work to be performed and exclusive of any part into which the application for permit may subdivided.
- 7. Inspections performed outside the Town of Erin (ie. Buildings to be moved to the Town of Erin), will be charged \$75.00/hour, plus the current Town of Erin mileage rate, OR, the inspection may be done by the municipality where the building is located and a copy forwarded to the Town of Erin.
