TOWN OF ERIN WATER RESOURCE RECOVERY FACILITY - TREATED EFFLUENT SEWER

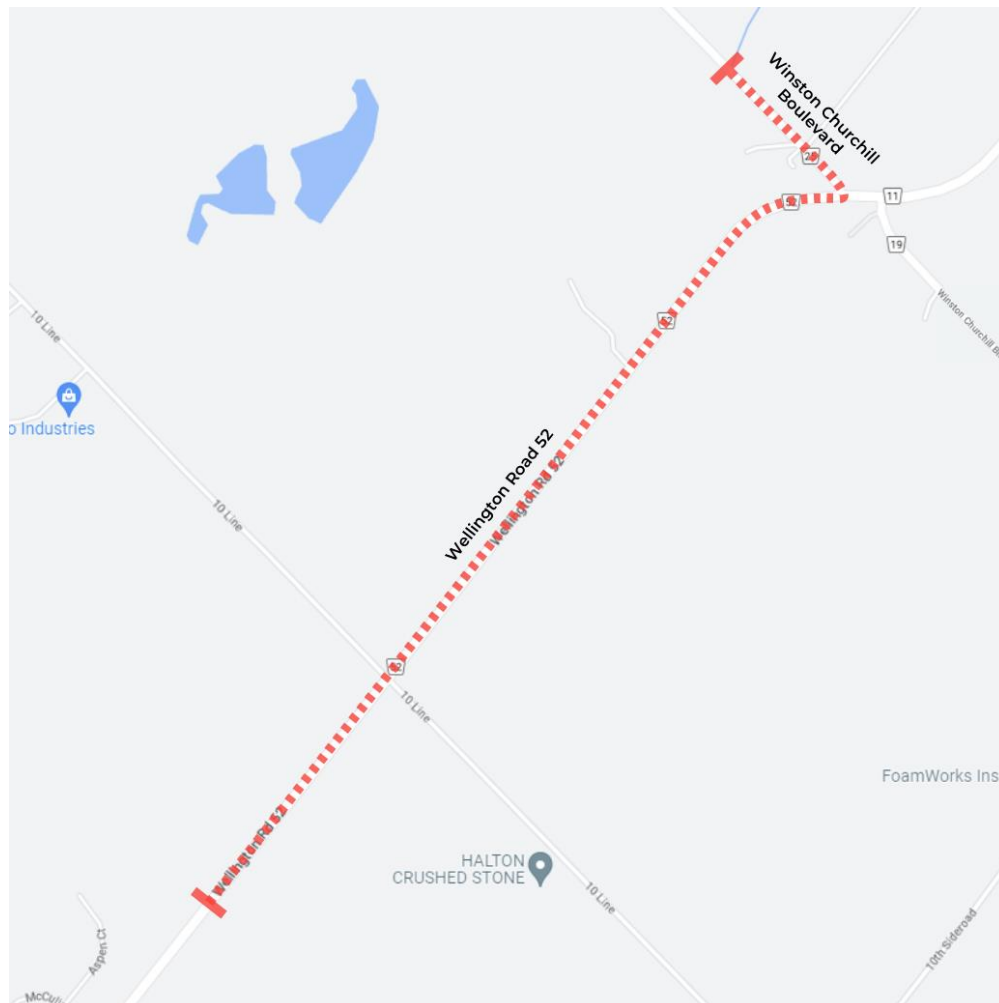

Installation of the treated effluent sewer from the Erin Water Resource Recovery Facility (WRRF) along Wellington Road 52 and Winston Churchill Boulevard in the Town of Erin, identified by the red line on the map below, is anticipated to commence in early April 2023. Lane closures and short-term temporary road closures will be required throughout the course of construction, but access to local homes and businesses as well as emergency services will be maintained at all times.

Anticipated End Date: September 2023

WORK DETAILS



The Town's Contractor will be installing sanitary twin forcemains and a gravity sewer to convey treated effluent from the Erin WRRF along Wellington Road 52 and Winston Churchill Boulevard to the West Credit River (approx. 2 km).

Starting in April 2023, the Town's Contractor will close off the work area by reducing traffic flow to one lane, move equipment on-site and prepare the work area before construction begins. Construction crews will then:

- Install sediment and erosion control measures
- Excavate and install forcemain and gravity sewer pipe as well as two chambers
- Reconstruct the roadway
- Complete final site works and restore disturbed areas to original or better condition

WHAT TO EXPECT DURING CONSTRUCTION

- Staged lane closures and short-term temporary road closures will be required along Wellington Road 52 and Winston Churchill Boulevard from the Erin WRRF to the West Credit River. One-way traffic will be maintained on Wellington Road 52 except for temporary road closures required to install chambers and maintenance holes. Winston Churchill Boulevard and 10th Line will also be closed to through-traffic for the work required on those roads.
- **Local access for residents, businesses, emergency vehicles and pedestrians will be maintained at all times. Road signs will notify drivers of upcoming road closures.**
- During the temporary road closures, through-traffic will be required to follow detour routes which will be clearly marked with traffic signs along the approach roads into the work area. Detour routes for vehicular traffic are posted on the Town's website.
- You may experience other inconveniences such as increased truck traffic, dirt on roads, dust and noise. The Town, along with the Contactor, will make every effort to minimize these impacts to the community.
- The Town will not be responsible for damage to any privately owned items on Town or County property.
