5. Business Items

5.1 Environment Grant update

- Still requiring grant template and minor edits from Matthew (due April 5th)
- Matthew should consult the United Nations Environment Program for grant examples (include link)
- Jen will release the application to all schools in Erin (April 11th)
- Deadline for grant application will be April 28th
- Decision will be made during May ESAC meeting
- The next intake will be in November

5.2 Earth day update – Abel

- Volunteer sign-up has been shared with all ESAC members
- Neighbouring high school is coordinating a paper shredding event
- Approximately 20 vendors attending
- Must touch base with the legion about advertising the upcoming Earth Day Event on their front sign
- Event has been shared on the Town of Erin, Community Calendar
- Julie will share Art Installation at the Legion, focusing on species at risk in the Credit River (approximately 14 feet)

5.3 Rain barrels update – Martin / Abel

- Martin inquired on the distribution process of rain barrels in neighbouring cities
- Many larger cities have a designated staff member to deliver rain barrels, which would not be practical in the town of Erin
- ESAC is currently required to meet with buyer at the Town and deal with the funds ourselves
- Town confirmed they do not have space for storage and that staff would not be able to assist with any tasks related to the sale of rainbarrels (beyond ordering)
- Some disappointment expressed towards the Town's effort after they showed so much interest last year
- Potential in contacting Wellington county to support the sale of rain barrels or other organizations such as Rotary Club (did it in the past) or others
- The rain barrel program received praise from members, however the current

system makes sales difficult.

• Committee voted in majority that the rain barrel program will be discontinued and revisited in the future eventually, to focus on other topics that the town is more enthusiast about.

5.4 Shamrock Award Decision

5.5 Turtle signs

• Committee will sell the remaining stock of turtle signs at 10\$ each during our Earth Day Event to gauge price efficiency.

5.6 Social media update

- Will require more posts for upcoming Earth Day Event

- Martin will lead the event, with Gavin & Julie

- Identify species and climate change goals tangibly to specific locations within the town
