The permit required for pool and hot tub installation is a "Pool Enclosure Permit". Below please find a checklist for requirements for the application.

A permit must be obtained from the Town of Erin **BEFORE** any pool or swimming pool enclosure (fence) is installed where the depth of water exceeds 2 feet (0.6m)

Requirements for Pool Enclosure Permit application:

<u>Check</u>

- Completed pool and hot tub application form.
- Completed undertaking and indemnification form.
- Owners/agent authorization (if applicant is someone other than property owner).
- Site plan, drawn to scale, maximum page size 17x11 (tablet). The site plan of your property to include:
 - a. Locations and shape of:
 - i. Proposed pool
 - ii. Fence and gate
 - iii. Septic system (tank and bed) iv. Existing building(s)
 - v. Indicate any proposed changes in grading
 - b. Setback distances from edge of pool to:
 - i. Property Lines
 - ii. Existing structures/buildings iii. Septic system, tank (s) and bed
- The cost of the permit is **\$330**. The fees cover the review of drawings for building code compliance, the building permit and building inspections.
- Municipal grading/damage deposit of **\$5,000** refundable at completion of final inspection required for all in-ground pool installations and heavy machinery use.

Approval from the local Conservation Authority may be required.

Forward all required application forms, drawings, fees and municipal property damage deposit to the Building Department at the Municipal Office located at 5684 Trafalgar Road Hillsburgh, Ontario.

Once a complete permit application has been submitted, the permit will be reviewed by staff. Please allow minimum 10 business days for permit processing. Excavation may not begin before the permit is issued. If you have any questions, please do not hesitate to contact us.
